- Preprocessing: data was rescaled
- Features are ranked using the Fisher Criterion: $R(f) = \frac{(\mu(f^+) - \mu(f^-))^2}{var(f^+) + var(f^-)}$

approach

- The number of features was determined by cross validation
- Classification was done by SVMs (linear or RBF)
- Heuristic used to find σ: Let t_i denote the distance of point x_i to the set formed by the points of the other class. σ is set to the mean of t_i.







- Arcene: rescaled. 4700 features. SVM linear C=inf
- Dexter: 3700 features. SVM linear C=inf
- Dorothea: rescaled. 1000 features. SVM σ =0.11 C=10 (+balanced)
- Gisette: rescaled. 700 features SVM σ =0.38 C=inf
- Madelon: rescaled 20 features. SVM σ =0.01 C=inf
